2. Risk Of Loss. The risk of loss from any casualty to the Goods, regardless of the cause, will be the responsibility of the Buyer once the Seller has shipped the goods, FOB Kent, OH.

3. Acceptance. Buyer will have the right to inspect the goods upon receipt, and within two (2) business days after delivery, Buyer must give notice to Seller of any claim for damages on account of condition, quality, or grade of the goods, and Buyer must specify the basis of the claim in detail. Failure of Buyer to comply with these conditions will constitute irrevocable acceptance of the goods by Buyer.

4. Payment. Goods shall be paid for when ordered. Payment may be made with Visa, Mastercard, American Express, Discover or Paypal. Payment by business check will be accepted, but shipping will be delayed until the check is cleared.

5. Warranty. Seller warrants that the goods sold hereunder are new and free from substantive defects in workmanship and materials. Seller's liability under the foregoing warranty is limited to replacement of goods or refund of the purchase price at Seller's sole option. Seller makes no other warranty, express or implied, and none shall be imputed or presumed.

6. Taxes. All duties, tariffs, and other governmental charges shall be paid by Buyer and are Buyer's Responsibility.

7. Governing Law. This Contract shall be governed by the laws of the State of Ohio. Any disputes hereunder will be heard in the appropriate federal and state courts located in Ohio.

8. Cancellation. Seller may, without liability or notice, delay performance or cancel this Contract at Seller's discretion.

9. Professional Use. By signing this contract, Buyer agrees that these products are for professional use only, and are not for resale. Violation of this will terminate the contract and could result in legal action.

10. Indemnification: Buyer shall indemnify and hold harmless TDL, its employees, consultants and agents for all proceedings, causes of action, suits, damages, losses, liability, costs and expenses, including reasonable attorney's fees and costs, whatsoever that may arise, either directly or indirectly, in performing its obligations under this Agreement, regardless of whether such proceedings arise in tort, contract, equity, under any statute, common law, or otherwise. Buyer acknowledges that TDL does not maintain insurance to cover Buyer, its property or employees.

11. Miscellaneous. This Contract contains the entire agreement between the parties and supersedes and replaces all such prior agreements with respect to matters expressly set forth herein. No modification shall be made to this Contract except in writing and signed by both parties. This Contract shall be binding upon the parties and their respective heirs, executors, administrators, successors, assigns and personal representatives.
