2. **Risk of Loss:** The risk of loss from any casualty to the goods, regardless of the cause will be the responsibility of the buyer once the seller has shipped the goods, FOB Kent, OH.

8. **Cancellation:** Seller may, without liability or notice, delay performance or cancel this contract at seller's discretion.
9. **Professional Use:** By signing this contract, buyer agrees that these products are for professional use only, and are not for resale. Violation of this will terminate the contract and could result in legal action.
10. **Indemnification:** Buyer shall indemnify and hold harmless TDL, its employees, consultants, and agents for all proceedings, causes of action, suits, damages, losses, liability, costs, and expenses, including reasonable attorney's fees and costs, whatsoever that may arise, either directly or indirectly, in performing its obligations under the agreement.
